Ms Mahlatse Shokane Wins the SAIGA 2024 Most Impactful Associate Award

Experimental Farm Manager Participates in the Human Rights Commission Indaba

From November 26th to 28th, 2024, various stakeholders, including the University of Venda from across Limpopo gathered with the South African Human Rights Commission (SAHRC) for an Indaba aimed at addressing the issue of instability and violence within farming communities. This crucial gathering focused on fostering dialogue and understanding in an effort to create lasting solutions to the tensions that persist in agricultural areas. By engaging in discussions such as these, the Faculty of Science, Engineering, and Agriculture (FSAE) is fulfilling its mission to produce well-rounded agricultural scientists and farmers while tackling critical issues such as inequality in the agricultural sector.

One of the key speakers at the event was Ms Thifheli Kutama, the Faculty of Science, Engineering and Agriculture (FSAE) Farm Manager, who was invited to share insights on the impact of farm violence on food security.

She underscored the importance of stability within farming communities to ensure food security during her address. According to Ms Kutama, a peaceful and stable environment is critical for agricultural productivity, and it is essential that all stakeholders work together rather than against each other.

She expressed concern that more than 30 years into South Africa's democracy, the country and Limpopo still find themselves engaged in difficult conversations about farm murders and attacks. This prolonged instability is not only a tragedy for those directly affected but also threatens the country's broader agricultural and food systems. Ms Kutama called for unity among all individuals, regardless of race, to bring an end to these violent incidents, which continue to plague the farming communities.

She also emphasised farm workers' crucial role in the country's food production system. Their well-being and protection are central to the sustainability of food systems in South Africa, as mistreatment of farm workers remains a significant issue in the country. Eliminating violence and improving labour conditions are vital steps towards achieving Sustainable Development Goal 2, which aims for zero hunger and food security for all by 2030.

The Indaba concluded with closing remarks from Mr Victor Mavhidula, the Limpopo Provincial Manager of the South African Human Rights Commission. He reinforced the importance of accountability, urging all participants to discuss these issues and take tangible steps toward implementing the solutions discussed during the sessions. Mr Mavhidula stressed that food security is a fundamental human right that should be accessible to everyone, regardless of background or socio-economic status.

He also reiterated the need for change within farming communities, highlighting the essential role of human rights in promoting a peaceful, equitable environment for all involved in agriculture. The discussions throughout the Indaba were a call to action for the stakeholders present to embrace transformation and prioritise human dignity, justice, and inclusivity.

The South African Human Rights Commission (SAHRC) was established by Chapter 9 of the Constitution of the Republic of South Africa in 1996, with a mandate to promote, protect, and monitor human rights within the country.



Over the years, the SAHRC Limpopo Provincial Office has received numerous complaints from farming communities about human rights violations. These complaints often involve allegations of abuse of farm workers, racial slurs, assaults, and unlawful evictions without proper legal processes. Many of these incidents have been investigated, and some have even been brought to the Equality Court.

The SAHRC has expressed concern about how these incidents affect social harmony and nation-building efforts, particularly in Limpopo Province. The increasing divide between farm owners, who are often white, and farm workers, who are predominantly black, continues to fuel tensions within the farming sector. Such incidents threaten the safety of individuals and impede the progress of a united, stable South Africa.

The discussions at the Human Rights Commission Indaba were essential to the ongoing effort to address the critical challenges faced by farming communities in Limpopo and across the country. The collaboration between various stakeholders—from the SAHRC to agricultural leaders like Ms Thifheli Kutama—emphasises the need for dialogue, unity, and action to create safer, more equitable environments within the agricultural sector. Only through these collective efforts can South Africa hope to achieve long-term stability in farming communities and ensure that food security becomes a reality for all.
